

in consideration of SEVEN THOUSAND FIVE HUNDRED AND NO/100THS - - - - - - - - - - Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

ALVIN D. GREEN, his heirs and assigns:

ALL that certain piece, parcel or lot of land situate, lying and being in Butler Township, Greenville County, State of South Carolina, containing 3 acres, more or less, according to a plat of Alvin D. Green property prepared by C. O. Riddle, R. L. S. on September 23, 1966, recorded in the R. M. C. Office for Greenville County in Plat Book NNN at \_, and having according to said plat the following courses and distances Page to-wit:

BEGINNING at an iron pin on the eastern side of Verdin Road, at the joint corner of Murphy N. Pitts property, and running thence along said road N. 3-05 W. 193.7 feet to an iron pin; thence along the line of Wealthy H. Green property S. 74-18 E. 757.4 feet to an iron pin; thence S. 13-16 W. 83.7 feet to an iron pin on the northwest side of East Butler Road; thence S. 13-16 W. 44 feet to the center of said road; thence S. 52-16 W. 70 feet along the center of said road; thence N. 74-15 W. 31.3 feet to an iron pin on the edge of said road; thence along the line of property of William M. Cox and Murphy N. Pitts N. 74-15 W. 627 feet to the point of beginning.
