the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Ronald L. Morrow and Martha S. Morrow, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in and adjacent to the City of Greenville, County of Greenville, State of South Carolina, on the western side of Monteith Circle and being known and designated as Lot No. 9 on plat of property of O. Y. Brownlee, H. C. Smith and C. S. Fox recorded in the R. M. C. Office for Greenville County in Plat Book "Q", at Page 164, and having, according to said plat, the following metes and bounds, to wit:
