WHEREAS, J. J. LOFTIS died testate November 1, 1928, as is evidenced by his Probate Record which is filed in Greenville County Probate Court in Apartment 237, File 36, leaving all of his real property to his wife, MARY LOFTIS, during her widowhood or for her lifetime in the event that she did not remarry, and then to his children, MAMIE LOFTIS GREEN, MARKLEY LOFTIS, BEN LEWIS LOFTIS, CRYSTAL LOFTIS, JOHN SLOAN LOFTIS, AND ALLIE LOFTIS, in equal shares. Mary Loftis died in October, 1961. Mamie Loftis Green died intestate January 26, 1951, as is evidenced by her Probate Record filed in Greenville County Probate Court in Apartment 598, File 48, leaving two (2) children, WALTER F. GREEN AND GERTRUDE GREEN, as her sole heirs-at-law. Walter F. Green died testate in June, 1966, as is evidenced by an exemplified copy of his Probate Record located in Greenville County Probate Court leaving his entire estate to his wife, MARTHA GREEN. Markley Loftis died intestate May 27, 1966, leaving as his sole heirsat-law his wife, MAGGIE LOFTIS, and three (3) children, PRIDE LOFTIS, HAROLD LOFTIS AND EVERETTE LOFTIS, Ben Lewis Loftis died intestate February 11, 1955, leaving as his sole heirs-at-law his wife, BEULAH LOFTIS and two (2) children, LEWIS GEORGE LOFTIS AND FANNIE FRANCES BATSON.

LOFTIS, CRYSTAL LOFTIS BOLING, ALLIE LOFTIS CHARPING, GERTRUDE GREEN JONES, MAGGIE LOFTIS, PRIDE LOFTIS, HAROLD LOFTIS, EVERETTE LOFTIS, BEULAH LOFTIS, LEWIS GEORGE LOFTIS, FANNIE FRANCES LOFTIS BATSON, and MARTHA GREEN, in consideration of TWENTY EIGHT THOUSAND FIVE HUNDRED FIFTY AND NO/100THS DOLLARS (\$28,550.00), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto DIXIE ENTERPRISES, INC., its successors and assigns forever:
