to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FOUNTAIN INN FROZEN FOOD PLANT, INC., Its Successors and Assigns Foever:

ALL that lot of land situate on the Northeast side of U.S. Highway No. 276 in the Town of Fountain Inn, in Greenville County, South Carolina being shown as a tract of 7.65 acres on a plat of the property of Thomas W. Richardson Estate made by C. O. Riddle, Surveyor, July 1966, recorded in the RMC Office for Greenville County, South Carolina in Plat Book MMM , page 118, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of U.S. Highway No. 276 at the South east corner of a 7.36 acre tract shown on said plat and runs thence along the line of the 7.36 acre tract, now property of the grantor N. 25-15 E. 490.5 feet to an iron pin; thence S. 77-08 E. 567.9 feet to an iron pin; thence along the line of an 11.12 acre tract, now property of the grantor S. 25-15 W. 696 feet to an iron pin on the Northeast side of U.S. Highway No. 276; thence along the right of way of said Highway S. 35-22 W. 15 feet to an iron pin; thence still along the right of way of said Highway No. 276 N. 54-38 W. 560.8 feet to the beginning corner and contains 7.65 acres according to the survey and plat referred to above.

This is a portion of the property conveyed to me by deeds of James B. Richardson et al. to be recorded herewith.

Together with an easement for ingress and egress over that 50 foot wide road extending from the Northwest corner of the above described tract in a Northeasterly direction to McCarter Road as shown on the plat mentioned above. This road is to be used in common with the grantor herein and his heirs and assigns and with any person or corporation that may be granted the right to use said mad by the grantor herein, his heirs and assigns.
