ALL that lot of land with the buildings and improvements thereon, situate on the North side of Airport Road (sometimes referred to as Lowndes Hill Road) in the city of Greenville, County of Greenville, South Carolina, being shown as Tract 2 and 4 on plat made by Pickell & Pickell Engineers on May 27, 1964, revised through October 14, 1966, recorded in the RMC Office for Greenville County S. C. in Plat Book NNN page 22 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Airport Road at the corner of Tract No. 1, said property also being 161.3 feet West from corner, property of T. M. and E. W. Bailey, and runs thence along the line of Tract No. 1 N 19-07 W 214 feet to an iron pin; thence N 72-10 W 193.5 feet to an iron pin; thence N 17-50 E 200.5 feet to an iron pin on the South edge of the right-of-way of C&WC Railroad (now Atlantic Coast Line Railroad) thence along South edge of right-of-way N 72-10 W 668.6 feet to an iron pin; thence S 23-15 E 261.3 feet to an iron pin; thence N 80-06 E 182 feet to an iron pin; thence S 23-15 E 150 feet to an iron pin; thence N 80-03 E 93 feet to an iron pin; thence S 13-23E37.3 feet to an iron pin; thence N 80-06 E 123 feet to an iron pin; thence S 13-24 E 186.5 feet to an iron pin; thence N 81-43 E 135 feet to an iron pin; thence S 13-24 E 170 feet to an iron pin on the North side of Airport Road; thence along the North side of Airport Road; thence along the North side of Airport Road N 81-14 E 89.9 feet to the beginning corner.
