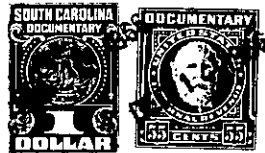

ALL that certain lot of land lying in the Fairview Township, County of Greenville, State of South Carolina, on the Western side of Putman Road, lying North of and adjacent to a lot previously conveyed by the Grantor herein to the Grantee herein, which previous deed is recorded in the R. M. C. Office for Greenville County in deed book 656, page 347. The previous conveyance is shown as the Northern most lot on a plat of property of Johnny Putman by Robert Jordan, dated September 11, 1957. The property herein conveyed has the following metes and bounds:

BEGINNING at a point near the center of Putman Road, at the Northwestern corner of Grantee's lot above referred to and running thence with Grantee's lot, S. 68-45 W. 209 feet to an iron pin; thence along other property of the Grantor, N. 21-15 W. 20 feet to an iron pin; thence N. 68-45 E. 209 feet to a point near the center of Putman Road; thence with the center of said Road, S. 21-15 E. 20 feet to the point of beginning.
