in consideration of -- THREE THOUSAND TWO HUNDRED AND FIFTY AND NO/100(3, 250,00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto IDA MAE P. CANNON, HER HEIRS AND ASSIGNS FOREVER:

ALL THOSE CERTAIN PIECES, PARCELS, OR LOTS OF LAND SITUATE, LYING AND BEING AT THE SOUTHERN CORNER OF THE INTERSECTION OF EDWARDS ROAD AND A FIFTY FOOT STREET IN CHICK SPRINGS TOWNSHIP, GREENVILLE COUNTY, SOUTH CAROLINA, BEING KNOWN AND DESIGNATED AS LOT NUMBER THREE (#3) AND THE NORTHWESTERN PORTION OF LOT NUMBER TWO (#2) ON A PLAT OF PROPERTY OF P. M. & LOIS GARRISON MADE BY J. MAC RICHARDSON, SURVEYOR, DATED JULY 1959 RECORDED IN THE R. M. C. OFFICE FOR GREENVILLE COUNTY, SOUTH CAROLINA, IN PLAT BOOK "TT" AT PAGE 123 AND, HAVING ACCORDING THERETO THE FOLLOWING METES AND BOUNDS, TO WIT:

BEGINNING AT AN IRON PIN AT THE SOUTHERN CORNER OF THE INTERSECTION OF A FIFTY FOOT STREET AND EDWARDS ROAD AND RUNNING THENCE S. 71 - 32 E. 100 FEET ALONG THE SOUTHWEST SIDE OF EDWARDS ROAD TO AN IRON PIN; THENCE RUNNING S. 66-35 E. 50 FEET STILL CONTINUING WITH SOUTHWESTERN SIDE OF EDWARDS ROAD TO POINT ON THE FRONT LINE OF LOT NUMBER TWO (#2); THENCE RUNNING S. 29-00W. 182.4 FEET TO AN IRON PIN LOCATED IN THE REAR LINE OF LOT NUMBER TWO (#2) BEING THE REAR CORNER of property now or formerly owned by Mack A. Ashmore; thence running N. 65-11 W. 150 feet along line of said Ashmore property to an iron PIN ON THE SOUTHEASTERN SIDE OF AFOREMENTIONED FIFTY FOOT STREET; THENCE running N. 29 - 20 E. 170.5 feet along said southeastern side of said FIFTY FOOT STREET TO AN IRON PIN AT THE SOUTHERN CORNER OF THE INTERSECTION OF SAID FIFTY FOOT STREET AND EDWARDS ROAD, THE POINT OF BEGINNING.
