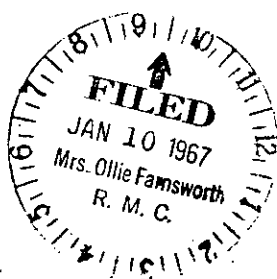

in consideration of - - Eight Hundred Seventy-five and No/100 (\$875.00) - - - - - Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Brent A. Angel or Pauline G. Angel, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 51 as shown on a Plat of Oxford Estates subdivision, recorded in the R. M. C. Office for Greenville County in Plat Book W, at Page 158, and having according to said plat the following description, to-wit:

BEGINNING on Caroline Street at an iron pin at joint front corners of Lots 49 and 51 and running thence 80 feet with the line of Caroline Street to an iron pin at joint front corners of lots 51 and 53; running thence 139.8 feet with the side line of lot 53 to an iron pin at joint rear corners of lots 51, 53, 54 and 52; running thence 80.4 feet with the rear line of lot 52 to an iron pin at joint rear corners of lots 52, 50, 49 and 51; running thence 142.4 feet with the side line of lot 49 to the iron pin at joint front corners of lots 49 and 51, on Caroline Street, the point of beginning.



NO residence to cost less than \$8,500.00 shall be erected on said lots; no residence shall be erected on any lot unless said lot has 50 feet, or more, frontage; no residence shall be built on any lot nearer than 30 feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business building shall be erected on any lots other than lots fronting on Staunton Bridge Road.

THIS conveyance is subject to all easements and rights of way of record. Grantee to pay taxes for 1967.
