the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto M. L. LANFORD, JR., his heirs and assigns forever:

ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number Three (3) of Section Two (2) of Chanticleer, Inc., as shown by a plat thereof made by R. K. Campbell, dated August 30, 1965, and recorded in the R. M. C. Office for Greenville County in plat Book "JJJ" at pag 71; and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the North side of Chapman Road at the joint front corners of Lots 4 and 3 and running along said lot lines thence N 10-40 W 242.5 feet to an iron pin; thence turning and running along the rear lot line of Lot No. 3 S 79-48 E 210.1 feet to an iron pin at the joint rear corners of Lots 3 and 2; thence turning and running along said lot lines S 12-17 W 183.8 feet to an iron pin; thence turning and running along Chapman Road S 83-55 W 65 feet to an iron pin; thence continuing along Chapman Road S 75-51 W 60 feet to an iron pin at the point of beginning.

This property is subject to easements and restrictions shown on said plat and to restrictive covenants recorded in the R. M. C. Office for Greenville County in Vol. 784 at page 329.

This is a portion of the property conveyed to Audubon Forest, Inc., by F. H. Earle by deed recorded in said R. M. C. Office in Vol. 700 at page 383. The name of Audubon Forest, Inc. was changed to Chanticleer, Inc. by instrument recorded in said R. M. C. Office in Vol. 712 at page 481.

This is one of the lots conveyed by Chanticleer, Inc., to Chestnut Hills, Inc. Chestnut Hills, Inc., by amendment of charter, changed its name to Chanticleer Real Estate Co.
