KNOW ALL MEN BY THESE PRESENTS, that We, James P. Robinson, George Robinson, Geneva R. Mackey, Sadie R. Haywood and Catherine Robinson

in consideration of One dollar (\$1.00) and correction of deed Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Walter L. Williams and Mary Lee Williams, their heirs and assigns.

WHEREAS by deed dated October 24, Recorded October 27, 1966 in the R. M. C. Office for Greenville County in Deed Book 808 at Page 307, the above named grantors convey the herein below described property to Willie Lee Williams; whereas Willie Lee Williams and Walter L. Williams are one and the same person and the grantee's correct name is Walter L. Williams, and whereas certain other defects existing in said deed, this deed is executed to correct the name of the intended grantee and to correct the errors existing in the afore mentioned deed.

All that piece, Parcel or lot of land in the County of Greenville, State of South Carolina in Paris Mountain Township, near Motor Boat Club Road, and being more particularly described as Lot Number Two (2), according to a plat of the property of Ed Robinson's Estate by Carolina Engineering and Surveying Company, September 27, 1966, and having the following metes and bounds, to wit:

Beginning at an iron pin on the Eastern edge of a proposed road at the joint front corner of Lots Number One (1), and Two (2) and running thence along the joint line of said Lots S. 82-00 E. 200.0' to an iron pin; thence S. 8-00 W. 100.0' to an iron pin; thence N. 82-00 W. 200.0' to an iron pin on the Eastern edge of a proposed road; thence along and with the Eastern edge of said proposed road N. 8-00 E. 100.0' to an iron pin, the beginning corner.

Being a portion of a 10 acre tract of land conveyed to Ed Robinson by the Independent Guano Company by deed recorded in the R. M. C. Office for Greenville County in Deed Book 194 at Page 39. The said Ed Robinson died intestate on or about November 17, 1952 leaving as his sole heirs at law the above named grantors and Edna Washington, all of which more fully appears in the record of the Probate Court of Greenville County in Apt. 622 File 13.
