KNOW ALL MEN BY THESE PRESENTS, that I, Wallace F. Pate,

Thirty Five Thousand Eight Hundred Thirty Five and 45/100 (\$35,835.45) Dollars, and assumption of mortgage

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release Carl Dennett Blyth, his heirs and assigns forever:

All those pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina in Paris Mountain Township on the south side of Roe Ford Road and being known and designated as Lot No. 58 and the western portion of Lot No. 57 on plat of Stratford Forest recorded in the R. M. C. Office for Greenville County in Plat Book "KK" at Page 89, and having, according to said plat, the following metes and bounds, to-wit:

LOT NO. 58: BEGINNING at an iron pin on the south side of Roe Ford Road at the joint front corner of Lots Nos. 57 and 58 and running thence along the joint line of said lots S. 12-25 W, 295.5 feet to an iron pin; thence N. 74-08 W. 233 feet to an iron pin; thence along the joint line of Lots Nos. 58 and 59 N. 21-45 E. 291.2 feet to an iron pin on the south side of Roe Ford Road; thence along the south side of said Road S. 76-18 E. 184.9 feet to the point of beginning.

WESTERN PORTION OF LOT NO. 57: BEGINNING at an iron pin on the south side of Roe Ford Road at the joint front corner of Lots Nos. 57 and 58 and running thence along the joint line of said lots S. 12-25 W. 295.5 feet to an iron pin; thence S. 74-08 E. 102.2 feet to an iron pin; thence through Lot No. 57 N. 13 E. 297.4 feet to an iron pin on the south side of Roe Ford Road; thence along the south side of said Road N. 75-40 W. 103.1 feet to the point of beginning.

The above is the same property conveyed to the grantor by deed recorded in Deed Book 769, at Page 80.

As part of the consideration of this conveyance the grantee assumes and agrees to pay the balance due on the mortgage over the above property to Fidelity Federal Savings and Loan Association recorded in Mortgage Book 826, at Page 16, the balance now due and owing being \$29,164.55.

This conveyance is subject to any restrictions, rights-of-way or easements of record. Grantee agrees to pay 1967 County taxes.
