KNOW ALL MEN BY THESE PRESENTS, that I, J. P. Medlock, of Greenville County,

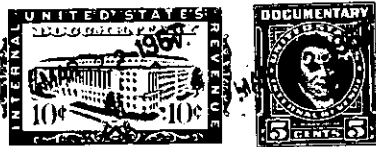
in consideration of Sixteen Thousand, Five Hundred and No/100----- Dollars,
