

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville on the northeastern corner of Sulphur Springs Road and Courtland Drive, being the southwestern portion of that certain lot shown and designated as Lot Number Five (5) on a plat of "High-view Acres" subdivision, recorded in Plat Book 0 at page 123, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a point, stake, northeastern corner of intersection of Sulphur Springs Road with Courtland Drive, and running thence N. 87-00 E. 90.3 feet along the northern side of Sulpher Springs Road to point, iron pin, joint front corner with other property of Grantors; thence N. 1-42 W. 246.2 feet along western line of said other property of Grantors, to a point, iron pin, in branch; thence along and with said branch as the line, in a northwesterly direction, 80 feet, more or less, to a point in branch, iron pin on bank, in the eastern side of Courtland Drive, and which point is 285.6 feet northeasterly from the point of beginning; thence S. 5-30 W. 285.6 feet along the eastern side of Courtland Drive to the point of beginning.

Being the same property conveyed to grantors, James Melvin Darby and Betty L. Darby by Deed recorded in Deed Book 477 at page 381 in the RMC Office.

ALSO: All that lot of land in the County of Greenville, State of South Carolina, known as a portion of Lot 5 of Highview Acres, recorded in plat Book 0 at page 123, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northern side of Sulphur Springs Road at the corner of James and Betty Darby property, which iron pin is situate 90.3 feet east of Courtland Drive, and running thence along Sulphur Springs Road, N. 87 E. 136 feet to an iron pin in the line of Lot 4; thence along the line of Lot 4, N. 3 W., 224 feet to an iron pin; thence along property of G. R. Owens in a northwesterly direction 112.4 feet to an iron pin at the rear corner of James and Betty Darby property; Thence along their property, S. 1-42 E., 246.2 (over) together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s') heirs, successors and assigns, forever.
