the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

W. B. Ellenburg and Erna R. Ellenburg, their heirs and assigns forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 64, as shown on a Plat of Pinewood Estates by H. S. Brockman, Surveyor, dated November 7, 1958 and recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 55, and having according to said plat the following description, to-wit:

BEGINNING on Earlene Drive at joint corners of lots 35 and 64 (at an iron pin) and running thence 80 feet with the line of Earlene Drive to an iron pin at joint front corners of lots 64 and 63; running thence 170 feet with the side line of lot 63 to an iron pin at joint rear corners of lots 63, 64 and 66; running thence 124.5 feet with the rear lines of lots 66 and 65 to an iron pin at joint rear corners of lots 65, 34 and 64; running thence 175.8 feet with the rear lines of lots 34 and 35 to the iron pin at joint corners of lots 35 and 64 on Earlene Drive, the point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 35 feet to the front line; no residence shall be built on any lot unless said lot has 70 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only:
