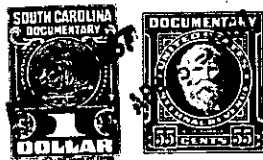
KNOW ALL MEN BY THESE PRESENTS That OLLIE FARNBORTH

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto John W. And Evelyn M. Ray, their heirs and assigns forever:

All that piece, parcel and lot of land lying, situate and being in the County of Greenville, State aforesaid, in a subdivision known as Caesar's Head; and being shown on a plat by T. Craig Keith, September 16, 1966, as the property of Jack W. Ray, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book \_\_\_ at page \_\_\_, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin near the corner of Sunrise Drive, N. 23-59 E. 99.4 feet to an iron pin; thence N. 66-10 W. 50 feet to an iron pin; thence S. 88-39 W. 122 feet to an iron pin; thence directly South 13.3 feet to an iron pin; thence S. 53-15 E. 158.8 feet to the point of beginning.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') heirs or successors and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
