unto LANSING T. HALL and ELIZABETH E. HALL, their heirs and assigns forever:

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina being known and designated as Lot 239, on Plat of Sector V, Botany Woods, which plat is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "YY" at Pages 6 and 7, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Rollingreen Road, joint front corner of Lots 238 and 239 and running thence N. 37-48 W. 175 feet to an iron pin; thence N. 52-12 E. 70 feet to an iron pin; thence 57-18 E. 152.2 feet to an iron pin on Rollingreen Road; thence along Rollingreen Road S. 20-24 W. 59.8 feet to an iron pin; and continuing thence with Rollingreen Road S. 52-12 W. 70 feet to an iron pin, the point of beginning.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record, on the recorded plat(s) or on the premises.

As a part of the consideration hereof, the Grantees agree to assume and pay, according to its terms, that certain note and mortgage given to Fidelity Federal Savings and Loan Association, on which there is a balance due of \$18,583.92; said mortgage being recorded in Mortgages Volume 912 at Page 448.
