ALL OF MY RIGHT, TITLE AND INTEREST IN AND TO THE WITHIN DESCRIBED PROPERTY:

ALL of that tract of land in the County of Greenville, State of South Carolina, in O'Neal Township on the northern side of Pine Log Ford Road and containing approximately 12 or 13 acres and being shown on the County Block Book as Sheet 499.1-1-30.4. This is the same property described in Deed Books 687, page 127; 654, page 187 and 204, page 356.

The purpose of this deed is to remove any cloud upon the title by reason of the language contained in the deed of David H. Styles to Arrielle Lawrence, wherein the above described property was conveyed to her in Deed Book 204, page 356, wherein David H. Styles retained a life estate and apparently retained the right of sale.

David H. Styles died on July 23, 1958, leaving no widow but leaving four children, or their heirs, as follows: Charles Layton Styles, a son; Vennie S. Eaton, a daughter; Alice Benson Styles, a son who died on February 3, 1924, leaving a wife and children; and Arrielle Styles Lawrence, a daughter, who died in 1954.
