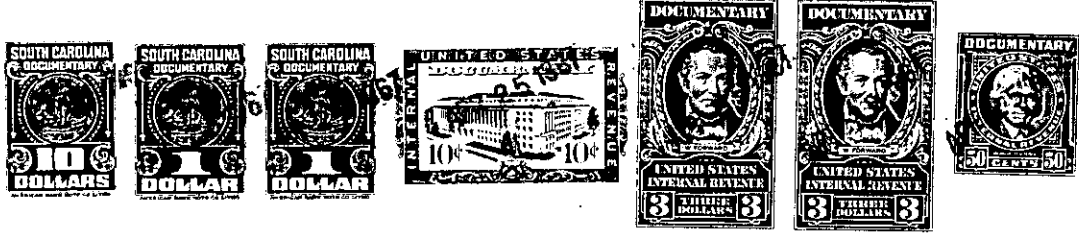
HAZEL A. VANCE, her heirs and assigns forever,
