

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, situated on the easterly side of Augusta Road and being known and designated as Lot No. 30 as shown on a plat of a subdivision of Elizabeth E. Voyles, said plat being recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "Y" at page 73, and having, according to said plat, the following metes and bounds, to-wit:
