the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

Billy G. Peeler and Frances S. Peeler, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, situated just below the town of Piedmont, South Carolina, being known and designated as Lot No. 43 of a subdivision known as Monticello Estates, as shown by a Plat thereof, by Woodward Engineering Co., dated March 1956, and recorded in the R.M.C. Office for Greenville County, in Plat Book EE, at Page 169, and having according to said plat the following description, to-wit:

Lot 43 Monticello Estates:

BEGINNING on West Monticello Road at an iron pin at joint front corners of Lots \$\mu2\$ and \$\mu3\$ and running thence 80 feet, more or less, with the line of said Road to an iron pin at joint front corners of lots \$\mu3\$ and \$\mu4\$; running thence 203.7 feet, more or less, with the side line of lot \$\mu4\$ to an iron pin at joint rear corners of lots \$\mu3\$, \$\mu4\$, \$\mu4\$, 27 and 28; running thence 80.2 feet, more or less, with the rear line of lot 28 to an iron pin at joint rear corners of lots 28, 29, \$\mu2\$ and \$\mu3\$; running thence 209.7 feet, more or less, with the side line of Lot \$\mu2\$ to the iron pin at joint front corners of lots \$\mu2\$ and \$\mu3\$ on West Monticello Road, the point of beginning.
