WassomApril 1962, and runs thence with the said road, S/63-66 W. 467 feet to a nail and cap in the center of the said road; thence N. 23-36 W. 666 feet to a point on the south side of the branch (iron pin back on line at 12 feet); thence with the following traverse line down the branch (the branch being the property line), N. 42-26 E crossing the branch to a stke on the north side of the branch; thence N. 64-56 E. crossing the branch twice, 266 feet to a stake on the north side of the branch; thence N. 78-65 E. 123 feet to a stake on the northern side of the branch; thence S. 51-16 E. 86 feet to an iron pin on the south bank of the branch, joint corner of the said Wasson tract; thence with the Wasson line, S. 24-15 E. 584.6 feet to the beginning corner (iron pin on line back at 24.3 feet), containing Seven and Thirteen One-hundredths (7.13) acres, more or less.
