Construction Company ---A Corporation chartered under the laws of the State of South Carolina ---- and having a principal place of business at Greenville ---, State of South Carolina ----, in consideration of Thirty-one Thousand and No/100 (31,000.00) ------Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and Ray Clary, his heirs and assigns forever.

ALL that piece, parcel or lot of land situate, lying and being on the northwestern side of Edgewood Drive in the Town of Mauldin, in the County of Greenville, State of South Carolina and known and designated as Lot No. 1 of a subdivision known as an Addition to Knollwood Heights by plat dated June 2, 1966 and revised April 11, 1967 by Piedmont Engineers and Architects and according to said revised plat has the following metes and bounds, to-wit:

BEGINNING at a point on the northwestern side of Edgewood Drive at the joint front corner of Lots Nos. 1 and 2 and running thence N. 47-27 W., 165 feet to a point; running thence S. 39–21 W., 159.47 feet to a point on the northeastern side of Knollwood Drive; running thence with said drive S. 61-45 E., 85 feet to a point; running thence with the said drive S. 58-04 E., 50 feet to a point at the intersection of Knollwood Drive and Edgewood Drive which intersection is curved the chord of which is N. 82-14 E., 38.5 feet to an iron pin on the northwestern side of Edgewood Drive; running thence with the northwestern side of Edgewood Drive N. 42-33 E., 99.4 feet to an iron pin, point of beginning.
