the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto 101 East North Street Corporation, its successors and assigns

All its right, title and interest in and to all that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being in the northeast corner of the intersection of East North Street and North Brown Street in the City of Greenville, County of Greenville, State of South Carolina and having the following metes and bounds to wit:

BEGINNING at an iron pin on the northeast corner of the intersection of East North Street and North Brown Street, and running thence with East North Street, S. 69-15 E. 51 feet to a point; thence in a line parallel with North Brown Street, N. 21 E. 90 feet to the southern boundary of an alley; thence with said alley boundary in a line parallel with East North Street, N. 69-15 W. 51 feet to an iron pin on North Brown Street; thence with North Brown Street, S. 21 W. 90 feet to the beginning corner.

The herein named grantee is to pay the 1967 taxes on the above described property.

The above described property is subject to a perpetual covenant running with the land reserved by R. E. Houston to himself, his legal representatives, heirs or assigns set out definitively in deed from R. E. Houston to Professional Building Company, dated April 7, 1919, recorded in Deed Vol. 44 at page 484, R.M.C. Office, Greenville County, South Carolina.

It is the intention of the grantor in this deed to convey all of the right, title and interest of the Estate of R. E. Houston in and to the above described property to the grantee(s).
