in consideration of Seven Thousand, Nine Hundred and 00/100 (\$7,900.00) - - - - the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

Jimmie T. Stewart, his heirs and assigns: ALL that certain lot of land lying in the State of South Carolina, County of Greenville, containing 35.1 acres, more or less, and being the remaining portion of a 55-1/2 acre tract conveyed to the late E. E. Thomason by deed recorded in the R.M.C. Office for Greenville County in deed book 50, page

5, after deducting from said 55-1/2 acre tract, a tract of 20.40 acres conveyed by the said E. E. Thomason to A. M. Stewart by deed recorded in the R.M.C. Office for Greenville County in deed book 259, page 95.

The original 55-1/2 acre tract is described as follows:

BEGINNING at an iron pin on line of Davenport's and Lot 2 of said division of lands and running thence S. 24-1/2 E. 44.40 ft. to an iron pin; thence N. 56-1/2 E. 12.80 ft. to an iron pin; thence N. 21 W. 38.10 to an iron pin; thence S. 54 W. 7.06 ft. to an iron pin; thence N. 80-1/4 W. 10.00 ft. to the beginning corner.

The aforesaid 20.40 acre tract excluded herefrom is described as follows:

BEGINNING at an iron pin on the Cobb line and corner of Lot No. 4 and running BEGINNING at an iron pin on the Cobb line and tollic road; thence along said thence N. 21 W. 29.71 ft. to a point in the public road; thence along said thence N. 21 E. 15.7 road, S. 73 W. 1.58 ft. to a point; thence leaving said road, S. 21 E. 15.72 to a stake; thence S. 56-30 W. 12.64 ft. to a stake; thence S. 24-30 E. 14.44 ft. to an iron pin; thence with the Cobb line, N. 56-30 E. 12.80 ft. to the beginning corner.

The tract conveyed herein was devised by the said E. E. Thomason to his widow, Jennie B. (Mariah) Thomason and his daughter, Nannie Lou Thomason (now Porter) as will hereby appear by reference to Apartment 496, File 24, in the Greenville County Probate Court. The One-Half (1/2) interest of the said Jennie B. (Mariah) Thomason was subsequently inherited by the grantors as her only children, as will appear by reference to Apartment 991, File 3, in the Greenville County Probate Court.
