Stephens ALL that piece, parcel or lot of land, with all improvements thereon situate, lying and being on the western side of North Main Street in the City of Greenville, County of Greenville, State of South Carolina, as shown on plat of property of T. L. Ayers, Jr., J. F. Harrison, Wesley Harrison and J. B. Stephens dated September 13, 1967, prepared by H. C. Clarkson, Jr. and recorded in the Office of the R. M. C. for Greenville County in Plat Book RRR, at Page 161, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the western edge of the right-of-way of. North Main Street at the corner of property now or formerly of Trinity Lutheran Church and running thence with the line of said Church property N. 70-45 W. 210 feet to a stake; thence N. 17-47 E. 10 feet to a stake; thence S. 70-45 E. 10 feet to a stake; thence along the eastern edge of a 20 foot alley N. 17-47 E. 133.3 feet to a stake on the southern edge of the right-of-way of Academy Street Loop; thence S. 70-45 E. 203 feet to a stake on the western edge of the right-of-way of North Main Street; thence with the western edge of the right of way of North Main Street S. 19-00 W. 143.15 feet to the point of beginning.
