All that piece, parcel or lot of land situate, lying and being on the Southern side of Gary Avenue near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 22 as shown on Map No. One Cunningham Acres, prepared by C. O. Riddle, dated March 1966, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BBB at page 118, and having according to said plat the following metes and bounds:
