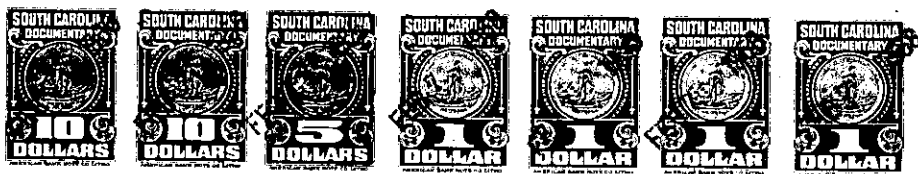
KNOW ALL MEN BY THESE PRESENTS, that Bobby R. Satterfield -----
