in consideration of Fifteen Hundred and No/100 (\$1500.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Chas. A. Mundy, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 66 of a subdivision known as Pine Hill Village as shown on plat prepared by R. K. Campbell, R. L. S., November 30, 1960, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ at Page 168, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Daisy Drive, joint front corner of Lots 65 and 66; and running thence along the joint line of said lots, N. 79-11 W. 140 feet to an iron pin, joint rear corner of Lots 135 and 134; thence along the rear line of Lot 134, S. 10-49 W. 70 feet to an iron pin at rear corner of Lot 67; thence along line of that lot, S. 79-11 E. 140 feet to an iron pin on the western side of Daisy Drive; thence along the western side of Daisy Drive, N. 10-49 E. 70 feet to the beginning corner.

This conveyance is subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 665 at Page 465 and Deed Vol. 703 at Page 351, and is also subject to utilities and drainage easements which appear of record. The rear 34 feet of this lot is affected by a right-of-way for a Duke Power Company transmission line, as shown on the recorded plat.
