ALL water lines, mains, valves and appurtenances installed and located in, under or along Ruby Drive and Long Forrest Drive in New Furman Heights Subdivision, County of Greenville, State of South Carolina and specifically including 1,430 feet - 2" Pipe; 762 feet - 1½" Pipe; 2 - 2" Valves; 1 - 1½" Valve; as shown on a plat entitled "W. E. Shaw & W. N. Leslie to Bera Public Service District", attached hereto and made a part of this conveyance.

TOGETHER with all pipes, valves and other mechanical parts and equipment appurtenant to said main and lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water main, pipe lines, and appurtenant equipment.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and Its Successors Heirs and Assigns forever.
