ALL water lines, mains, valves and appurtenances installed and located in, under or along Banner Drive, Blue Mist Drive, Lula Lane, Saran Drive in Lockwood Heights Subdivision in the County of Greenville, State of South Carolina and specifically including approximately 2,599 feet - 6" Pipe; 480 feet - 2" Pipe, 7 - 6" Valves; 2 - 2" Valves; 2 - Fire Hydrants; as shown on a drawing entitled "M.G.Thurston to Berea Public Service District", attached hereto and made a part of this conveyance. TOGETHER with all pipes, valves and other mechanical parts and equipment appurtenant to said main and lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water main, pipe lines, and appurtenant equipment.

On March 23, 1960, the abovementioned waterlines and appurtenances were owned by Lula B. Thurston and on that date I, as Committee for Lula B. Thurston (see Greenville County Probate Court records apartment 376, file 4), relinquished all rights and titles to the above water lines; this deed is given for thepurpose of confirming said release and placing it in such form as required for recording. The original conveyance having been made by the Grantor herein to Berea Water & Sewer District which by appropriate action is now known as Berea Public Service District Commission.
