the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Charles W. Mills and Anna P. Mills, their heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 148 of a subdivision known as Colonial Hills, Section No. 3, as shown on a plat thereof prepared by Piedmont Engineers & Architects, dated May 7, 1965, recorded in the R. M. C. Office for Greenville County in Plat Book BBB, at Page 91, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Ardmore Drive, joint front corner of Lots Nos. 147 and 148, and running thence along the joint line of said lots, S. 11-17 E. 173.9 feet to an iron pin; thence N. 78-16 E. 90.0 feet to an iron pin at the rear corner of Lot No. 149; thence along the line of that lot, N. 11-44 W. 175.0 feet to an iron pin on the southern side of Ardmore Drive; thence along the southern side of Ardmore Drive, S. 78-16 W. 67.1 feet to an iron pin; thence continuing along the southern side of Ardmore Drive, S. 75-20 W. 22.9 feet to the beginning corner; being the same conveyed to me by Williams Land Company, Inc. by deed dated November 1, 1967 and recorded in the R. M. C. Office for Greenville County.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat (s), or on the premises.
