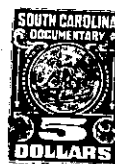

KNOW ALL MEN BY THESE PRESENTS, that I, William Vines Parsons, Jr.,

in consideration of Twenty Two Hundred Sixty Nine and 78/100 (\$2269.78)----- Dollars,  
and assumption of mortgage  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto

John William Jones and Nancy Myrl Roberson Jones, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the southwestern side of Pinefield Drive and being known and designated as Lot No. 189 on plat of S. Forest Estates, Addition No. 1, recorded in the R. M. C. Office for Greenville County in Plat Book "EE", at Page 195, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Pinefield Drive at the joint front corner of Lots Nos. 188 and 189 and running thence along the joint line of said lots S. 44-25 W. 230 feet to an iron pin; thence S. 50-13 E. 80.25 feet to an iron pin; thence along the joint line of Lots Nos. 189 and 190 N. 44-25 E. 223.5 feet to an iron pin; thence along the southwestern side of Pinefield Drive N. 45-35 W. 80 feet to the point of beginning.

The above is the same property conveyed to the grantor by deed recorded in Deed Book 775, at Page 70.

This conveyance is subject to such restrictions, easements or rights of way as may appear of record and specifically an easement for a power transmission line as shown on said plat.

As part of the consideration for this conveyance the grantees assume and agree to pay the balance due on the mortgage over the above property to Cameron-Brown Company recorded in Mortgage Book 996, at Page 623, the balance now due and owing thereon being \$ 14, 107. 11.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s) heirs or successors, executors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
