the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Truman Black, his heirs and assigns, forever.

All that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot 65 of Wellington Green, Section Two, as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book YY at Page 117 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Bridgeport Drive at the joint front corner of Lots 65 and 66 running thence along the line of Lot 65, S. 32-15 W. 165.0 feet to an iron pin; thence N. 60-20 W. 99.8 feet to an iron pin at the joint rear corner of Lots 64 and 65; thence along the line of Lot 64 N. 32-15 E. 170.0 feet to an iron pin on the southwestern side of Bridgeport Drive; thence along Bridgeport Drive S. 57-45 E. 100.0 feet to the beginning corner.
