KNOW ALL MEN BY THESE PRESENTS, that A. P. Owings

in consideration of \$1.00, love and affection for my mother Dollars,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Emma Owings, for and during her natural life,

All that piece, parcel or lot of land in the State of South Carolina, County of Greenville, on Bent Bridge Road, near the City of Greenville. This lot is better described by a plat prepared by W. D. McBrayer, which plat was made from a deed recorded in the RMC Office for Greenville County in Deed Book 45 at Page 121. This lot is a part of the aforesaid tract of land and is described as follows:

BEGINNING on the southwest side of said tract 150 feet from the corner of said tract and Bent Bridge Road, and running N. 5 W. 400 feet; thence E. 100 feet; thence S. 5 E. 400 feet to Bent Bridge Road; thence along Bent Bridge Road 100 feet to the beginning corner.

Being the same property conveyed to the grantor by deed of J. P. Owings, recorded in Volume 213 at Page 326.

Upon the death of the said Emma Owings, title to the above described property shall vest in the seven children of J. P. Owings, deceased, named in his will, filed as Apartment 598, File 58 in the office of the Probate Judge for Greenville County. The purpose of this deed is to vest in Emma Owings a life estate of record, then upon her death a fee simple title in the children of J. P. Owings, deceased, in accordance with his will referred to above.

Less, however, that strip of land crossing said lot which was deeded to S. C. Highway Department and now is a part of S. C. Highway 123.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs, successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs, successors and assigns against the grantor(s) and the grantor's(s') heirs, successors and assigns and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
