

ALL THAT CERTAIN piece, parcel, or lot of land, situate, lying and being, on the Northern side of Goodrich Street, in Greenville County, South Carolina, being shown and designated as Lot Number 38 on a Plat of "PROPERTY OF MOLLIE FORTNER, et. al. ANDERSON ROAD, Greenville County, South Carolina". made by R. E. DALTON dated July 1922, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book F, at page 73, and having according to said plat the following metes and bounds, to-wit:
