KNOW ALL MEN BY THESE PRESENTS, that we, Robert C. Harvey and Louise R. Harvey,

ONE and No/100 (\$1.00)-----and
in consideration of Assumption of mortgage as here and below set out. Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto James E. Pruitt, Jr. his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the south side of Highland Avenue (formerly Highlawn Avenue) and being known and designated as Lot No. 3, Block F, on plat of Riverside Subdivision recorded in the R. M. C. Office for Greenville County in Plat Book "K", at Pages 281 and through 284, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Highland Avenue at the joint front corner of Lots Nos. 2 and 3 and running thence along said Avenue S. 79-45 E. 50 feet to an iron pin; thence along the joint line of Lots Nos. 3 and 4 S. 10-15 W. 125 feet to an iron pin; thence N. 79-45 W. 50 feet to an iron pin; thence along the joint line of Lots Nos. 2 and 3 N. 10-15 E. 125 feet to the point of beginning.

This conveyance is made subject to restrictions, easements and rights-of-way appearing on record in the R. M. C. Office for Greenville County.

This being the same property conveyed to the Grantors herein by deed of Buster B. Brown, Jr. and Barbara A. Brown date May 24, 1968, and recorded in the R. M. C. Office for Greenville County in Deed Book 844, at Page 647.

As part of the consideration of the assumption, the Grantee assumes and agrees to pay the balance due on that certain note and mortgage by the Grantor herein to C. Douglas Wilson Company, Greenville, South Carolina, the original amount of \$ 6,500.00, dated May 24, 1968, and recorded in the R. M. C. Office for Greenville County in Mortgage Book _____ at Page _____.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)'s heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and fully defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
