All that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, shown and designated as Lot B on a plat of property prepared for Dan E. Bruce by Webb Surveying & Mapping Co., dated December 30, 1965, which plat is recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book MMM at Page 135, and having according to said plat the following metes and bounds, to-wit:

Beginning at the joint westerly intersection of Lot 21, property of Grantee, and Lot B and running thence S. 50-57 W. 46.8 feet to a point on the northern line of Lot N; thence turning and running S. 46-14 E. 91.1 feet to a point, joint intersection of Lots B, C and M; thence turning and running N. 50-57 E. 35 feet to a point at the easterly intersection of Lots 21 and B; thence turning and running N. 39-03 W. 90 feet to the point of beginning.
