the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Milton T. Arledge and Sylvia G. Arledge, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 68 as shown on a Plat of Chevy Chase dated July, 1963, by Dalton & Neves Engineers and recorded in the R.M.C. Office for Greenville County in Plat Book YY, at Page 121, and having according to said Plat the following description, to-wit:

BEGINNING on Chevy Chase Boulevard at an iron pin at joint front corners of Lots 69 and 68 and running thence 100 feet with the line of said Boulevard to an iron pin at joint front corners of lots 68 and 65; running thence 155 feet with the side line of lot 65 to an iron pin at joint rear corners of lots 65, 66, 67 and 68; running thence 87.5 feet with the rear line of lot 67 to an iron pin at joint rear corners of lots 67, 68 and 70; running thence 66 feet with the rear line of lot 70 to an iron pin at joint corners of lots 68, 69 and 70; continuing thence 130 feet with the side line of lot 69 to the iron pin on Chevy Chase Boulevard at joint front corners of lots 69 and 68, the point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on any lot unless said lot has 70 feet, or more, frontage; no residence shall be erected on said lot nearer than 35 feet to the front line; all lots to be used for residential purposes, only, except lots fronting on Augusta Road; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.
