the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto A. M. Ford, his heirs or assigns, forever.

ALL that certain piece, parcel or tract of land in Greenville County, State of South Carolina, located on the easterly side of S. C. Highway #417 and having, according to plat entitled "Property of Russell Q. Lewis", dated September 30, 1968, prepared by C. O. Riddle, the following metes and bounds, to-wit:

BEGINNING at a nail and cap at or near the intersection of S. C. Highway #417 and an old road and running thence N. 12-06 W. 241.1 feet with S. C. Highway #417; thence continuing with the center of S. C. Highway #417, N. 4-31 W. 322.5 feet to a point; thence continuing with the center line of S. C. Highway #417, 361.1 feet to an old railroad spike; thence continuing with the center line of S. C. Highway #417, N. 17-09 E. 257.5 feet to a point in center of bridge crossing Gilder Creek; thence with the center line of Gilder Creek, the meanders of which are as follows: S. 69-09 E. 95 feet to a point; S. 17-37 E. 94.8 feet to a point; N. 77-21 E. 70 feet to a nail and cap on bridge of old road; thence leaving said Gilder Creek and running with old road S. 12-06 E. 178 feet to a point on the easterly side of said old road; thence with the center line of said old road S. 17-35 W. 507.5 feet to an old nail and cap; thence continuing with center of said old road S. 18-00 W. 413.3 feet to a nail and cap at the intersection of old road and S. C. Highway #417, the beginning corner, said tract containing 5.1 acres, more or less, total, and containing 4 acres, more or less, to Highway #417 right-of-way.

Being a portion of the property inherited by the Grantor herein from Tirzah P. Lewis as shown by record of her estate filed in the Probate Court for Greenville County in Apartment 891 at File 24.
