

All that piece, parcel or tract of land on the southern side of Hudson Road, near the City of Greenville, in Greenville County, State of South Carolina, containing 17.01 acres, more or less, according to a survey prepared by Piedmont Engineers & Architects entitled "Property of McCall-Threatt Enterprises, Inc." recorded in Plat Book ZZ Zat page // and described as follows:

BEGINNING at a point in the center of Hudson Road and running thence S. 33-43 E. 338.3 feet to an iron pin; thence S. 0-42 E. 1125.8 feet to an iron pin; thence N. 75-55 W. 301.6 feet to an iron pin; thence N. 49-04 W. 532.9 feet to an iron pin; thence N. 34-21 W. 441.5 feet to a point in the center of Hudson Road; thence with the center of said Road the following courses and distances: N. 51-38 E. 400 feet, N. 49-34 E. 115.2 feet, and N. 46-19 E. 429.4 feet to the beginning corner.

The above described property is hereby conveyed subject to the right of way of the Hudson Road and to all utility rights of way and easements of record which affect said property.

It is the intention of the grantor to convey to the grantee any property in which he may have any right, title and interest on the southern side of Hudson Road, the above described property being a part of the same conveyed to the grantor by deed recorded in the RMC Office for Greenville County in Deed Book 177 at page 206.
