unto N. Q. CLINE AND MARTHA A. CLINE, their heris and assigns;

ALL that piece, parcel or lot of land on Paris Mountain, Greenville County, South Carolina, being lots 2, 3A and 3B as shown on plat of property of Dr. J. L. Sanders made December 15, 1960 with a revision April 1961, which has been duly recorded in Plat Book VV, at Page 32, and revised plat recorded in Plat Book AAA, page 55, and having according to Plat of Property of N. Q. Cline made by C. C. Jones Engineer, August, 1968, the following metes and bounds, to-wit:

BEGINNING at a bottle cap in Altamont Road and running thence with approximately the center of said Road S. 71-24 W. 232 feet to a bottle cap; thence still with approximately the center of Altamont Road S. 73-24 W. 184.9 feet to a bottle cap; thence still with said Road S. 57-41 W. 50 feet to a bottle cap; thence leaving said Road N. 27-29 W. 211 feet to joint corner of Charles L. Sanders; thence with the joint line of said property N. 71-06 E. 267.5 feet to an iron pin; thence N. 24-20 W. 20 feet to an iron pin; thence N. 25-26 W. 137.1 feet to an iron pin; thence N. 38-11 W. 98.6 feet to a bottle cap in Chesnut Ridge Road; thence approximately with center of said Road N. 66-35 E. 71 feet to a bottle cap; thence still in approximately in the middle of said Road N. 49-05 E. 71.5 feet to a bottle cap; leaving said road and running with the line now or formerly of Goldsmith S. 56-14 E. 166.5 feet to an iron pin; thence still with said line S. 41-07 E. 76 feet; thence S. 21-30 E. 287 feet to a bottle cap in Altamont Road, the point of beginning.
