KNOW ALL MEN BY THESE PRESENTS That G. G. Ebert & Betty M. Ebert in the State aforesaid,

in consideration of the sum of SIX THOUSAND THREE HUNDRED SIXTY-TWO and no/100(\$6,362.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto William K. Howle, his heirs and assigns forever:

All that certain lot of land lying in the State of South Carolina, County of Greenville, on the northern side of Beaufort Street, shown as Lot 118 on a Revised Plat of Heritage Hill, recorded in the R.M.C. Office for Greenville County in Plat Book YY at page 186 and being further described as follows:

BEGINNING at an iron pin on the northern side of Beaufort Street at the joint front corner of Lots 117 and 118 and running thence along the joint line of said lots, N. 17-40 W. 189.3 feet to an iron pin; thence S. 76-11 W. 77 feet to an iron pin; thence S. 65-53 W. 23 feet to an iron pin; thence along the joint line of Lots 118 and 119 S. 17-49 E. 195.7 feet to an iron pin; thence along the northern side of Beaufort Street, N. 70-00 E. 100 feet to the point of beginning. Being the same property conveyed to the said G. G. Ebert, et al, by deed recorded in Deed Book 783 at page 107.

The above conveyance is subject to all rights of way, Protective Covenants and easements recorded in the public records for Greenville County that affect the said property.

As part of the consideration for the foregoing conveyance the grantee assumes and agrees to pay the outstanding balance on a Note and Mortgage from G. G. Ebert, et al, to First Federal Savings & Loan Association in the original sum of \$21,250.00 dated September 24, 1965, recorded in the R.M.C. Office for Greenville County in Mortgage Book 1008 at page 660 and having a present balance of \$19,788.46.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, his Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
