KNOW ALL MEN BY THESE PRESENTS, that I, Ward S. Stone, of Greenville County

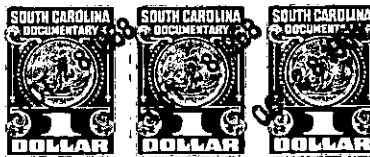
in consideration of Fifteen Hundred and No/100 (\$1500.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Chas. A. Mundy, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 63 of a subdivision known as Pine Hill Village as shown on plat prepared by R. K. Campbell, R. L. S., November 30, 1960, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at Page 168 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Daisy Drive, joint front corner of Lots 62 and 63 and running thence with the joint line of said lots, N. 79-11 W. 140 feet to an iron pin at the joint rear corner of Lots 62 and 63, said iron pin being in the center of a Duke Power Company right-of-way; thence with the center of said Duke Power Company right-of-way, which is the joint line of Lots 63 and 137, S. 10-49 W. 70 feet to an iron pin, joint rear corner of Lots 63 and 64; thence with the joint line of said lots, S. 79-11 E. 140 feet to an iron pin on the western side of Daisy Drive; thence with said Daisy Drive, N. 10-49 E. 70 feet to the beginning corner.

This conveyance is subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 665, at Page 465 and Deed Vol. 703 at Page 351, and is also subject to utilities and drainage easements which appear of record. It is further subject to a right-of-way to Duke Power Company.
