Kemp, in the State aforesaid, in consideration of the sum of Five (\$5.00) - - - - - DOLLARS, and other valuable considerations, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Louie R. Kemp and his heirs and assigns forever:

All of that parcel or lot of land in Highland Township of Greenville County, South Carolina, lying about 250 feet southeast of State Highway No. 14 and about ten miles north of the City of Greer, being shown as Lot No. 3 on a plat made for A. B. Kemp by W. N. Willis, Engineers, dated February 29, 1968, which plat is to be recorded herewith and having the following courses and distances:
