The expression or designation "Grantor" wherever used herein shall be understood to include the Mortgagee, if any therebe. 2. The right of way is to and does convey to the Grantee, its successors and assigns the following. The right and privilege of entering the aforesaid strip of land, and to construct and operate within the limits of same, pipe lines, manholes and any other adjuncts deemed by the Grantee to be necessary for the purpose of conveying sanitary sewage and industrial wastes, and to make such relocations, changes, renewals, substitutions, replacements and additions of or ro the same from time to time as sais Grantee may deem desirable; the right at all times to cut away and keep clear of said pipe lines any and all vegetation to maintenance; the right of ingress to and egress from said strip of land across the land referred to above for the purpose of exercising the rights herein granted so the rights herein granted shall not be construed as a waiver or abandonment of the right thereafter at any time and from time to time to exercise any or all of same. No building shall be erected over said sewer pipe line nor so close thereto as to impose any load thereon. 3. It Is Further Agreed And Understood: That upon completing the construction of the pipe lines, manholes and other adjuncts, or any relocation, change, substitution, etc., thereof, the premises shall, where possible, be restored to the condition in which it existed prior to the construction.
