KNOW ALL MEN BY THESE PRESENTS, that I, T. Dewitt Smith, Jr. of Greenville County

in consideration of Six Thousand, Seven Hundred Ninety-Three and 64/100 (\$6,793.64)----- Dollars, and assumption of mortgage set out below the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

John Benjamin Bolt, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, being known and designated as Lot No. 37 of Liberty Park, Map No. 2 as shown on plat thereof prepared by Dalton & Neves, Engineers, August 1958 and recorded in the R. M. C. Office for Greenville County in Plat Book MM at Page 39 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern edge of Valerie Drive, joint front corner of Lots Nos. 37 and 38 and running thence along the joint line of said lots and continuing along the joint line of Lots Nos. 37 and 39, N. 66-42 E. 180 feet to an iron pin at the joint rear corner of Lots Nos. 37 and 36; thence along the joint line of said lots, N. 38-38 W. 168.8 feet to an iron pin on the southern edge of Andrea Lane; thence along the southern edge of Andrea Lane, S. 54-15 W. 115 feet to an iron pin; thence following the curvature of Andrea Lane as it intersects with Valerie Drive, the chord of which is S. 17-0 W. 39.7 feet to an iron pin on the eastern edge of Valerie Drive; thence along the eastern edge of Valerie Drive, S. 20-15 E. 110 feet to the beginning corner;

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s), or on the premises.

As a part of the consideration for this conveyance, the grantee expressly assumes and agrees to pay the balance due on that certain note and mortgage, in the original sum of \$19,200.00 executed by the grantor to the First Federal Savings and Loan Association of Greenville and recorded in the R. M. C. Office for Greenville County in Mortgage Book 1098 at Page 401, the balance due thereon being the sum of \$19,006.36 as of this date.
