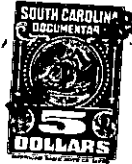

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto W. L. Burger,

All that lot of land in the county of Greenville, state of South Carolina on the southerly side of Barwood Circle, being known and designated as Lot No. 32 on plat of Barwood subdivision recorded in the RMC Office for Greenville County, S. C., in plat book 000, page 33, and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the southwest side of Barwood Circle, the joint front corner of Lots 31 & 32; thence with the joint line of said lots S. 58-29 W. 220 feet to an iron pin corner of Lot No. 33; thence with the line of said lot N. 31-31 W. 93.9 feet to an iron pin on the southeast side of Barwood Circle; thence with the curve of said street as follows: N. 56-22 E. 86.4 feet to a point; thence N. 61-40 E. 47.6 feet to a point; thence N. 69-17 E. 30.1 feet to a point; thence S. 88-15 E. 33.1 feet to a point; thence S. 73-01 E. 28.5 feet to a point; thence continuing with the southwest side of said Barwood Circle, S. 41-55 E. 51.5 feet to the beginning corner.

This lot is conveyed subject to the building restrictions recorded in deed vol. 844 page 339 and to recorded easements or rights of way. This is a portion of the property conveyed to the grantor by James Theodore by deed recorded in deed vol. 745 page 543 of the RMC Office for Greenville County, S.C.
