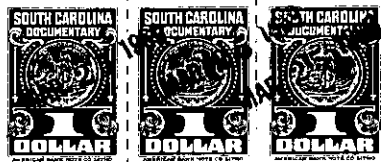
KNOW ALL MEN BY THESE PRESENTS, that I, Earl H. Ragsdale

in consideration of One Thousand Five Hundred and 00/100 (\$1,500.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William J. Vines, his heirs and assigns, forever:

"ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on waters of Mathers Creek, in the "Sunset Valley Sub-division", Block A, being known and designated as Lot No. 12, on plat of John C. Smith, Surveyor, dated July 1960 and being more fully described according to said plat as follows, to-wit: BEGINNING at an iron pin at Ragsdale Drive, common corner of Lots 12 and 13, the Northwestern corner of the lot herein described, thence North 28-21 East 100 feet with Ragsdale Drive to an iron pin; thence South 61-39 East 142 feet with line of Lot 11 to a point in center of creek; thence with creek South 32-55 West 100.3 feet to a point; thence, leaving creek, and crossing iron pin on bank, North 61-39 West 134 feet with line of Lot 13 to the point of BEGINNING at Ragsdale Drive; this being a portion of the "Old Tom Clark Place" conveyed to the grantor by deed of Rachel Howard."

The grantee, his heirs and assigns, by the acceptance of this conveyance is required to install any septic tank or other sewage disposal in accordance with the regulations of the State Board of Health, subject to inspection by local public health authorities.
