the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto WILLIAM L. BROCKMAN & LILA H. BROCKMAN,

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 58 of a subdivision known as Pine Hill Village as shown on plat prepared by R. K. Campbell, R.L.S., November 30, 1960 and recorded in the RMC Office for Greenville County in Plat Book QQ, at page 168, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of East Castle Road, joint front corner of Lots Nos. 58 and 191, and running thence along the joint line of said lots, S. 20-15 W. 109.0 feet to an iron pin, joint rear corners of Lots Nos. 191, 58 and 57; thence along the line of Lot No. 57, N. 79-11 W. 95 feet to an iron pin on the eastern side of Daisy Drive; thence along the eastern side of Daisy Drive, N. 10-49 E. 70 feet to an iron pin; thence following the curvature of the intersection of Daisy Drive with East Castle Road, the chord being N. 50-12 E. 35.6 feet to an iron pin on the southern side of East Castle Road; thence along the southern side of East Castle Road, N 89-26 E. 51.3 feet to an iron pin; thence continuing along the southern side of East Castle Road, S. 78-59 E. 40 feet to the beginning corner.

This is the same lot conveyed to grantor by Ward S. Stone by deed recorded Sept. 6, 1968 in deed book 851 page 554 of the RMC Office for Greenville County, S. C. and is conveyed subject to restrictions recorded in deed vol. 665 page 465 and 703 page 351, and to utility and drainage easements which appear of record.
