ALL that piece, parcel or lot of land near Travelers Rest in Greenville County, South Carolina located on Grand View Circle and known and designated as Lot No. 1 on a plat of property of James R. Crosby and Donald O. Kay according to survey prepared by Terry T. Dill, RLS, March 27, 1969, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Grand View Circle joint front corner of lots 1 and 2, which point is 391 feet along a course N. 15-00 W. from the northeastern intersection of Grand View Circle and State Park Road (Highway 23-22) and running thence along the joint lines of lots 1 and 2 N. 75-00 E. 252.5 feet to an iron pin joint rear corner of lots 1 and 2; thence N. 14-22 W. 16.5 feet to an iron pin; thence N. 39-45 E. 159.8 feet to an iron pin; thence N. 89-00 W. 398 feet to an iron pin on the eastern side of Grand View Circle; thence along the eastern side of Grand View Circle S. 15-00 E. 219 feet to the point of beginning.
